155. Planning Matters

(a) **Planning Applications**

<u>Resolved</u> that the comments as stated, be made to North Lincolnshire Council on the following Planning Applications:

- (1) <u>PA/2014/1016 Keigar Homes Ltd (Mr Mark Snowden)</u> Planning permission for substitution of house types including garages and drives to plots 52, 55-63, 77-85 and 106-108 and alterations to access road layout (previously approved under PA/2009/0257) at plots 52, 55-63, 77-85 and 106-108 inclusive off Falkland Way, Barton (No comment or objection);
- (2) <u>PA/2014/0677 Mr Darrell Lowe</u> Planning permission for the conversion/partial reconstruction of existing shop with flat over to create a further two flats at ground floor level including replacement of shopfront with a sliding sash window at 36 Fleetgate, Barton (Comment: it should be noted that the small plot of land on the corner of Fleetgate/Newport, adjacent to the development site is not to be used for any vehicular parking as is currently happening);
- (3) <u>PA/2014/1069 Graham Gibbs Associates (Mr Graham Gibbs)</u> Planning permission for extensions to lounge and entrance hall at 126 Tofts Road, Barton (No details of this application are available on the North Lincolnshire Council website to determine comment. In light of this, it was agreed that the Chairman, Councillor Mrs W Witter, be given delegated powers to make comment when the documentation is available on behalf of the town council. For report at the next meeting):
- (4) <u>PA/2014/1053 Redrow Homes Yorkshire</u> Application to modify Section 106 agreement attached to planning permission number PA/2003/0696 at Tofts Road, Barton (Objection: the developer has previously submitted a planning application in 2012 (*PA/2012/0920*) for the section 106 agreement to be modified. However, since then the site has continued to be developed. Numerous planning applications have been submitted for minor alterations and to vary the original planning consent, in order for the changes to allow the developer to sell the properties, which it has done considerably. In light of this, the town council objects to the current application);
- (5) <u>PA/2014/1029 Mr Roger Henderson</u> Notification of proposed work to fell 1 Ash Tree within the Barton-upon-Humber Conservation Area at 3 Pasture Road, Barton (Comment: the town council are very reluctant to see the removal of this tree, unless it is absolutely necessary).
