(a) Planning Applications

<u>Resolved</u> that the comments as stated, be made to North Lincolnshire Council on the following Planning Applications:

- (1) <u>PA/2017/1048 Mr David Snowden</u> Notice of intention to fell 10 trees within Barton-upon-Humber's Conservation Area at Bank House, 8 Holydyke, Barton (Objection: it is felt that loss of the trees would aid atmospheric pollution on a major road adjacent. If the trees are felled replacement trees need to be planted in place of, or some of the existing ones to remain in-situ);
- (2) <u>PA/2017/1046 Mr David Snowden</u> Planning permission for change of use of ground floor of former bank to two apartments, demolition of extensions to side and rear and erection of three town houses with associated parking at Bank House, 8 Holydyke, Barton (Objection: inadequate parking available on the site and road safety concerns of the access road onto Holydyke (A1077) a busy main road. There is no mention of the current vehicular access to the site or the side gate in the application and there is no room for refuse bins. It is felt the development proposals are too dense for the size and location of the plot. However, it is considered that development of the existing building for two apartments only is satisfactory);
- (3) <u>PA/2017/1140 Keigar Homes (Mr Garry Whall)</u> Notification of intention to undertake pruning works on 2 Ash trees within the Conservation Area of Barton-upon-Humber at land off Queen Street, Barton (Comment: for clarity, the tree T1 is located in a private garden (15 Queen Street) and was pruned on the private garden side of the tree earlier this year (*PA/2016/1922 refers*). The planning information is also incorrect as east and west appear to be wrongly shown);
- (4) <u>PA/2017/1161 Keigar Homes Ltd (Mr Mark Snowden)</u> Planning permission to erect a single-storey structure to enclose electricity sub-station at land off Plumleaf Way, Barton (No comment or objection);
- (5) <u>PA/2017/1153 Heathcliff Developments Ltd (Mr James Roger Carlton)</u> Notification for prior approval for a proposed change of use of offices to dwelling houses at 1 & 2 The Willows, Willow Drive, Barton (No comment or objection);
