The public right of way over the land situate at Barton-upon-Humber between on the one hand the B1218 Brigg Road and the western perimeter of the A15 dual carriageway and on the other the eastern perimeter of the A15 dual carriageway and its junction with the length of Public Bridleway 330 leading generally north towards Kingsforth Hall shown by a continuous bold line on the map attached to this order and described in Part 1 of the Schedule to this order shall be extinguished after seven days from the date of confirmation of this order and thereupon the 'County of Lincoln, Parts of Lindsey (Glanford Brigg)' definitive map shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.


