- c) **PA/2025/1393** – Consultation Modification or discharge of planning obligation at Phases 5 and 6, Falkland Way, land off Canberra View, Barton upon Humber DN18 5GR Application to modify the Section 106 Agreement (S106) attached to PA/2020/1628 for viability reasons in relation to affordable housing, leisure, education and public transport – **Committee object to this application.**
