- b) **PA/2025/1448** - Planning permission for change of use from Industrial (B2/B8) to Sports Hall / Padel Courts (E(d) Unit 1, Falkland Way, Humber Bridge Industrial Estate, Barton Upon Humber, DN18 5RL. – **Committee welcomes the application and another unit in use.**
